HB3245/SB568: BLOCK ILLEGAL OWNERSHIP (BIO) AND FIX THE FOID BILL

THE PROBLEM

Name-based background check searches can produce inaccurate records and take longer to complete. Ineligible persons can be issued FOID cards, evade the law and purchase firearms.

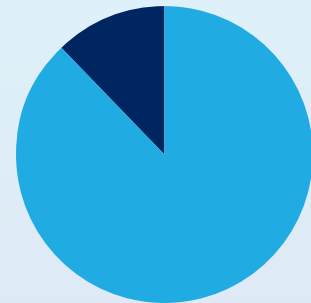
THE SOLUTION

Fingerprinting is the only form of background check search that verifies the identity and criminal history of FOID card applicants. This would better protect the public through rapid completion of background checks and efficient processing of FOID applications. The live scan fingerprint vendor fee is capped at \$30 in HB3245/SB568.

In Illinois, fingerprints are currently required for teachers, professions that work with children, health care workers, police officers, firefighters, park district employees, state employees, persons who operate gaming establishments, and people seeking licenses for a number of other occupations. HOW FINGERPRINTING PROTECTS THE PUBLIC:

- ▶ FOID card applicants submit fingerprints as part of their FOID application.
- ▶ Fingerprints are run against the FBI's National Crime Information Center (NCIC) database to ensure there is no prohibitive criminal record.
- ▶ If there is a criminal record match, then the individual will be denied a FOID card and cannot legally purchase a gun.
- ▶ Fingerprints are stored in the NCIC database without expiration in order for authorities from every state to run fingerprints against a single system. If an individual commits a crime in another state, the NCIC database will show the conviction thus closing any state-to-state loopholes.
- ▶ If a FOID card holder is later convicted of a crime, the FOID card is revoked and guns are removed by Illinois State Police.
