

Our One Job is to Keep Children Safe from Gun Violence

SUPPORT BLOCK ILLEGAL OWNERSHIP (BIO) AND FIX THE FOID BILL

IMPROVES PUBLIC SAFETY

- Requires background checks for all gun sales, including person-to-person, private sales. This tracking would improve firearm investigations and homicide clearance rates.¹
- Verifies the identity of FOID card applicants by requiring one set of fingerprints submitted to the Illinois State police. This would better protect the public through rapid completion of background checks and efficient processing of FOID applications. The live scan fingerprint vendor fee is capped at \$30.
- Enables Illinois State Police to remove guns once a FOID card is revoked, reducing illegal gun purchases and sales by ineligible FOID card holders.
- Dedicates life-saving, mental health funding for communities most impacted by gun violence.

ILLINOIS' PUBLIC HEALTH CRISIS

- The risk of homicide for domestic violence victims is 5 times higher² when there is a gun in the home. Domestic violence increased 16% in Illinois³ in 2020.
- Firearms continue to be the leading cause of death for Illinois children and teens.⁴ An average of 183 children and teens die by guns every year in Illinois.
- The state's gun violence disproportionately affects Black and Brown children and teens, who are 13 times more likely to die from gun violence than their white counterparts.⁵
- More than 27,000 Illinoisans may still be armed, despite losing their right to own a gun.⁶ Communities with the highest number of revoked FOID cards and illegal guns are Mount Vernon, Kankakee, Marion, and Streator.

FIX THE FOID ADDITIONS

- Provides solutions to FOID CARD and CCL License backlog.
- Allows for electronic cards, combined FOID/CCL cards, automatic FOID renewal with FTIPs or CCL renewal.
- Applicants can choose to access fingerprint on file and allows Illinois State Police to access Secretary of State database for FOID Card address updates.
- Creates permanent Appeals Board.

A strong gun licensing system combined with background checks on all gun sales is proven to cause a
